The Institute of Certified Records Managers (ICRM) is an international certifying organization of and for professional records managers. The Institute confers the Certified Records Manager (CRM) and Certified Records Analyst (CRA) designations.

The ICRM was incorporated in 1975 to meet the requirement to have a standard by which persons involved in records management could be measured, accredited, and recognizes according to criteria of experience and capability established by their peers.

The ICRM serves as the official certifying body for both the Association of Records Managers and Administrators International (ARMA) and the Nuclear Information and Records Management Association (NIRMA).

The ICRM is an independent, non-profit organization administered by a Board of Regents in accordance with the Constitution and By-laws of the Institute. The ICRM is a member of the National Certification Commission.

CRM's are knowledgeable and experienced in active and inactive records systems, including electronic records and information; regulatory compliance related to records and information requirements; and other related disciplines such as archives, micrographics, and digital imaging technology. Individuals earn the CRM (or CRA) designation by meeting both educational and work experience requirements established by the ICRM and by passing the required series of examinations.

In the state of Kentucky, there are currently twelve active CRM's and one active CRA. Louisville is home to five of these designees and all five belong to our Louisville ARMA chapter.
